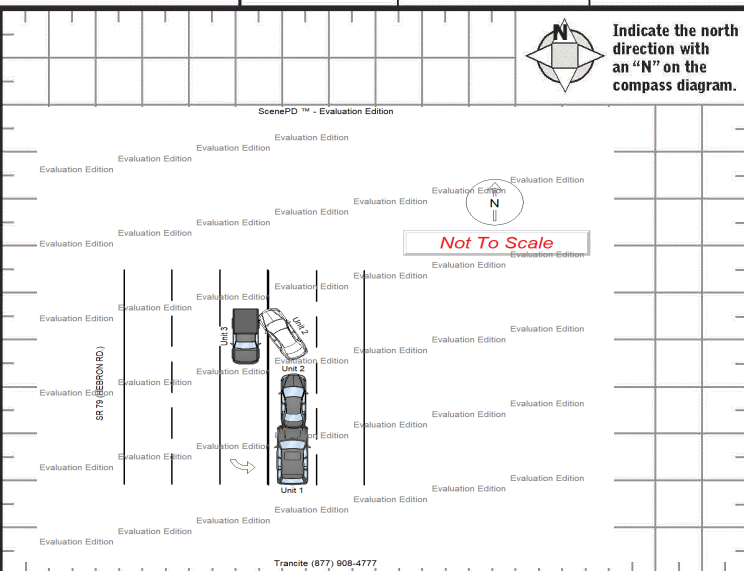

UNIT 1 DID NOT STOP IN TIME STRIKING THE REAR OF UNIT 2. UNIT 2 WAS THEN PUSHED IN TO UNIT 3 THAT WAS SOUTH BOUND IN THE LEFT TURN LANE TO TURN ON TO RIDGELY TRACT RD. 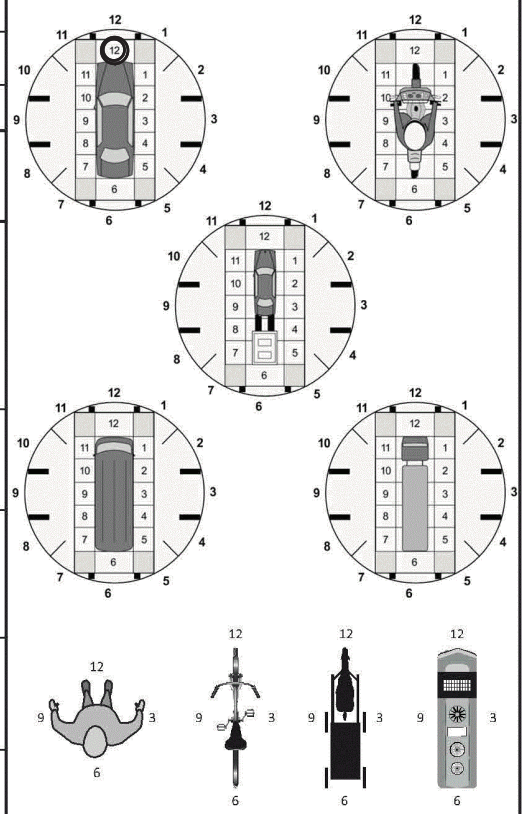
