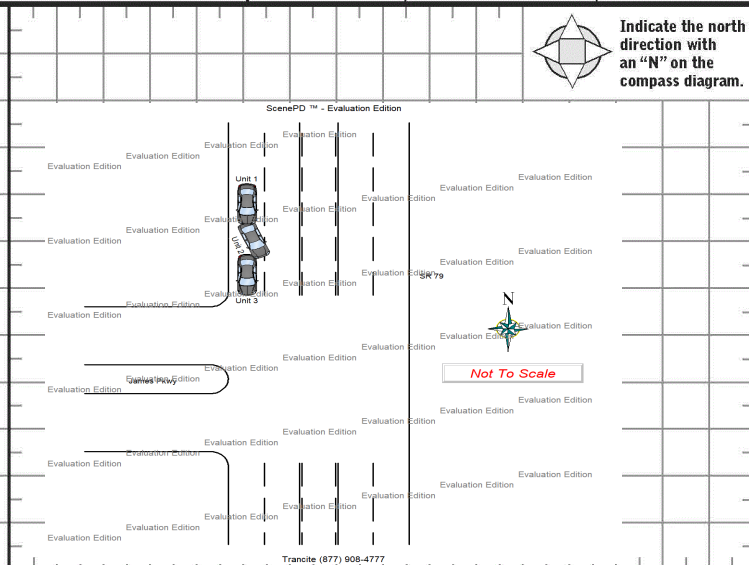

Unit one struck the rear of unit two. Unit two was forced forward, but swerved left in an attempt to avoid striking unit three. The front right of unit two struck the left rear of unit three.
