REGULAR COUNCIL MEETING

President Tim Kelley called The Regular Meeting of Heath City Council to order Jan. 17, 2023 at 7:30pm. The Pledge of Allegiance followed. The Invocation delivered by A. Porter. T. Dupps called the Roll Call with Council Members; Cole, Crabill, Lawson, Kelley, Moretti, Morrow, Porter. D. Morrow moved to approve the minutes of the Regular Meeting Jan 3, 2023 - Second by Crabill.
