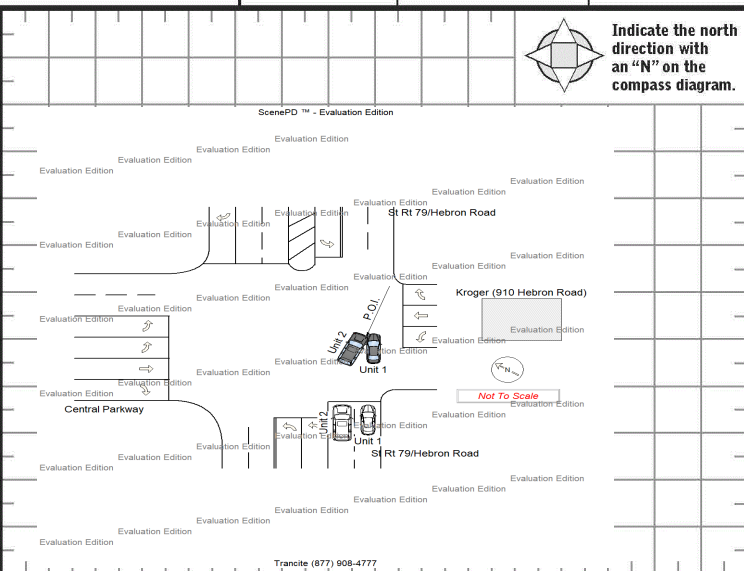

NARRATIVE
Unit #1 was stopped on northbound St Rt 79 for the red light at the Central Parkway intersection. Unit #1 was in the curb lane. Unit #2 was stopped in the left lane beside Unit #1. Both units received the green light and began to accelerate. Unit #2 did not see Unit #1 and attempted to merge into the right lane to turn right into a private business. Unit #2 struck Unit #1.
