REGULAR COUNCIL MEETING

President Pro-Tem D. Cole called The Regular Meeting of Heath City Council to order Nov. 6, 2023 at 7:30pm. The Pledge of Allegiance followed. The Invocation delivered by D. Morrow. T. Dupps called the Roll Call with Council Members; Morrow, Porter, Cole, Kelley, Roberts, Crabill, Moretti. Motion by Roberts to excuse Kelley. Second by Crabill. All in favor "aye" vote. Motion to excuse Kelley approved. Crabill moved to approve the minutes of the Regular Meeting Nov. 6, 2023. Second by Roberts. All in Favor "Aye" Vote. Minutes Approved. Mayor Johns, Auditor J. Morrow, and Law Director D. Morrison in attendance.

Public Services: D. Morrow met Oct. 23, 2023 at 5:28 p.m.

The Public Service Meeting was called to order at 5:28 p.m. Utilities Director John Geller presented a report on current and future needs for the city of Heath. First a test on the growth the last 10 years and current growth. Conclusion – Progress, but can we do better. He presented the needs for more water and wastewater infrastructure and the flow from the west end residential areas. Bullet points were presented on how to fund the projects. Pictures and reports on the new well tests. A concern was presented concerning the Hoback wells. Another test to follow. Finally, the long-awaited generator is scheduled to arrive July 28th, we hope. With no delinquents to report, the very informative meeting was adjourned at 6:59 p.m.

Streets & Drainage: J. Roberts met this evening at 5:31 p.m.

Superintendent of Parks & Streets Bob Geller first discussed that the city leaf pick up will be Nov. 13 and 14th. We were also given an update on the street paving which is wrapping up at this point. He also gave us 2024 street paving program. We discussed the purchase of 2 speed signs specific for Cynthia Street. We do have a speeding issue there and as everyone knows this is the main entrance to Geller Park. It is important that we try to address that situation. A discussion of replacement of signs through out the city due to reflectivity which makes signs useless, if you cannot see at night. The meeting adjourned at 6:05 p.m.

Community Development & Zoning: P. Moretti will meet Nov. 13, 2023 at 5:30 P.M.

<u>Parks, Recreation, and Davis Shai House:</u> D. Cole met this evening at 6:05 p.m. The following were discussed.

- 1.) Park Gate They received a check for the damage done while paving from Robertson Trucking for cost of the gate for \$6,925.40. Estimate for the park gate is \$25,084.23. Cost the city approximately \$18,500 after the damage check is applied.
- 2.) <u>Inclusive Playground</u> at Geller Park a check will be presented this evening which was done from the Licking County Foundation from representatives Amy Dell and Mike Schmidt who is the incoming President for the Licking County Foundation. We will sign an agreement with the Licking County Foundation for this. Installation apparatus is complete and the rest will be completed soon.
- 3.) <u>Pickle Ball Courts and Softball Fields</u> Jan Wilkin got a message from the state today regarding grants we asked about to assist with these projects. The deadline is April 1, 2024. Jan will take the lead on this.

Other Items:

We had a brief discussion about the Arts Council & Davis Shai House updates. Mark and Bob met with Denise about potential veranda enclosure or an additional building possibility. I also attended a meeting of The Arts Council where that was discussed. At this point we do not have any realistic options in place, so we will probably be looking at that down the road.

Councilmen Porter inquired and Bob reported meeting with Chad Hartley who represents HSYAA and working on a new 5-year agreement which starts 2024-2029 with HSYAA Sports.
