

# Reports of City Officials:

The one thing clear to me that our Police Department has is an excellent reputation among The Law Enforcement Community. There is no doubt that the compensation that council recently approved had a great impact on putting so many quality candidates in front of Chief and I. Myself, Price and Ginny will continue to work on negotiating this development agreement with the developer on this project and when we have a product that we feel is ready to move forward to you we will get it to your hands and review it. I am looking forward to that 3<sup>rd</sup> leg of the stool being added to the future project. Thank You to Dr. Thomas and The Heath City School District. We are fortunate in our community, that I believe to have a School District and a city government that historically have been so supportive of each other. Tonight, the School District Board is voting and City Council voting on the same agreement. I feel it's a great symbol of the cooperative that The Heath City School District and The City have had. I will say this when it comes up that you cannot have a strong city without a strong School District and you can't have a strong School District without a strong city.
