NARRATIVE

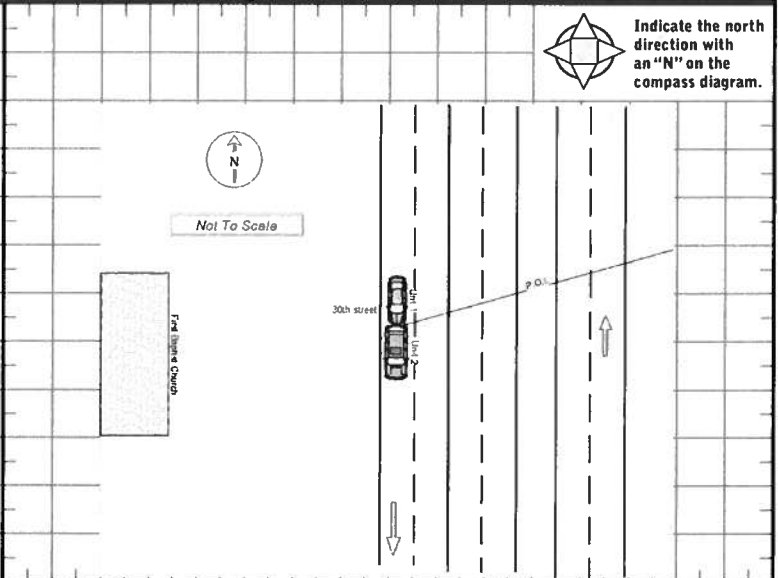

Unit 1 advised she was traveling south on 30th street when traffic had quickly came to a stop, Unit 1 advised she did not have enough time to get her vehicle to completely stop, then struck Unit 2 in the rear bumper. Unit 1 has disabling front end damage.

Unit 2 stated she was traveling S on 30th street then came to a complete stop when all of a sudden she was struck from behind pushing her vehicle slightly forward. Minimal damage was done to Unit 2's vehicle. A tow truck was requested for Unit 1. No injuries were reported.

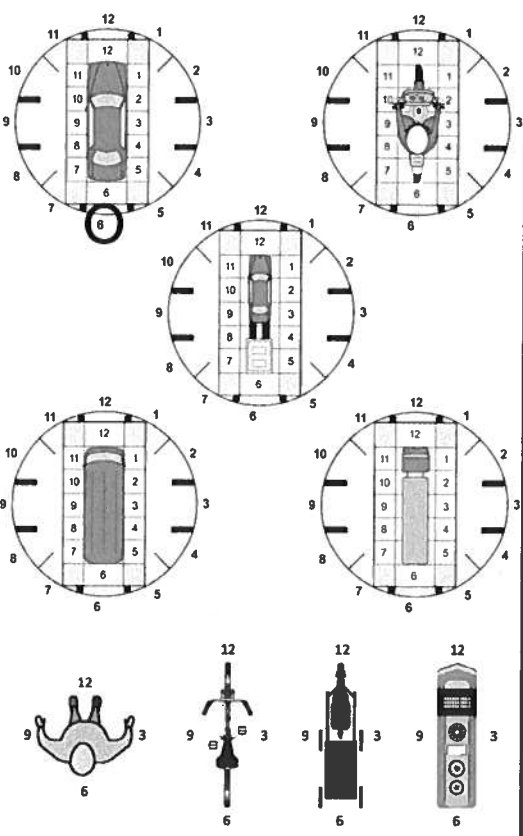
