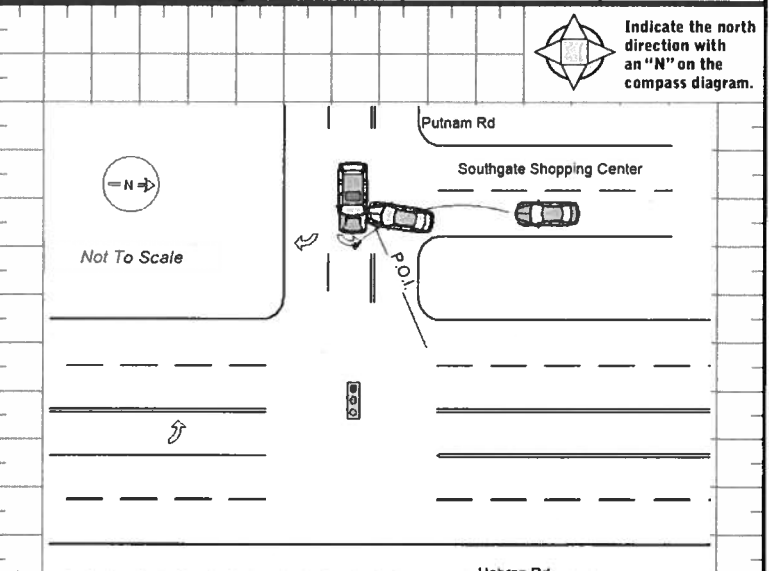

 On December 23, 2019 I was dispatched to the area of IHOP on a report of a non injury accident. Dispatch said that a white Subaru station wagon and a white Jaguar four door sedan were involved. I was able to locate both vehicles and driver's operating them.
 Unit 1 advised that she was making an attempt to turn left onto Putnam Rd. Unit 1 said she thought the roadway was clear and committed to make her left turn. Unit 1 did not see Unit 2's vehicle in time causing her vehicle to strike into Unit 2's driver side front.
 Unit 2 stated he was traveling east on Putnam Rd when Unit 1 pulled right out in front of his vehicle. Unit 2 did not have enough time to avoid contact with Unit 1.
 Both parties involved did not report any injuries. Minimal damage was observed on this date.

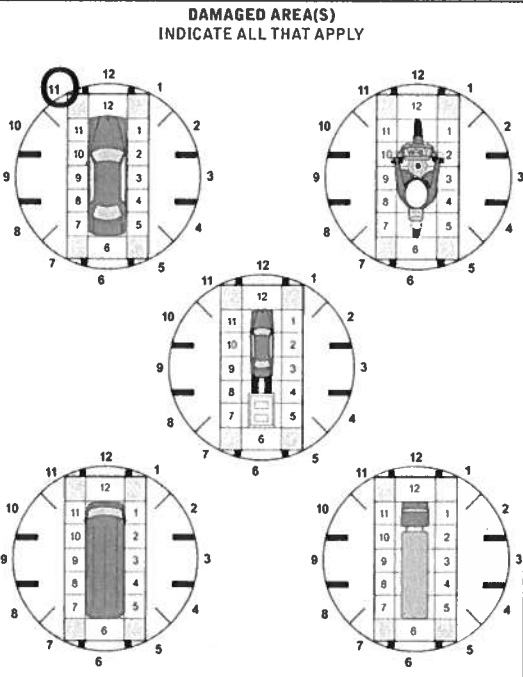

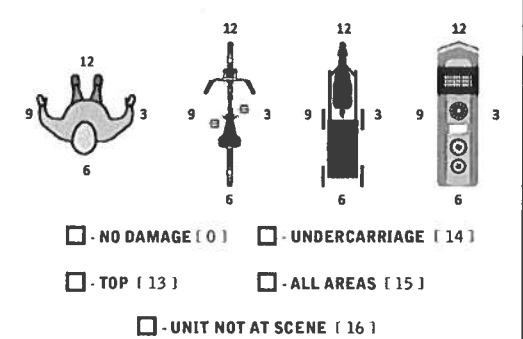
