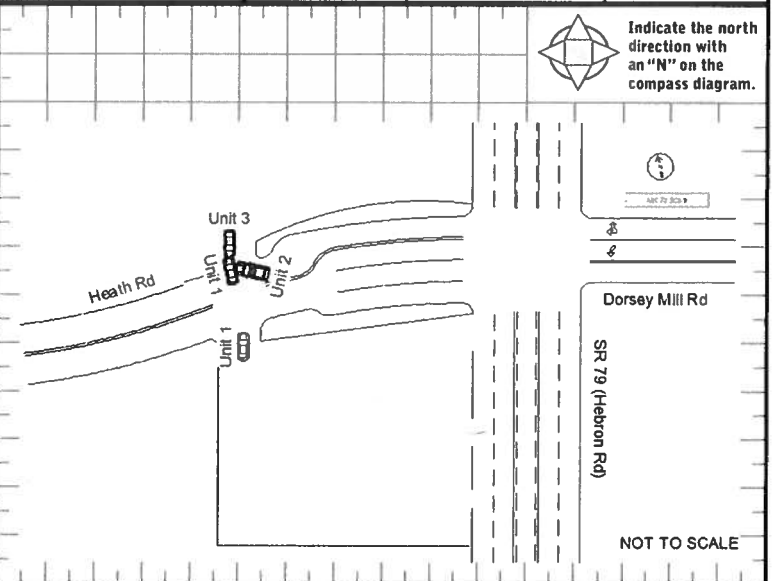

 Unit 2 was westbound on Heath Rd from SR 79. Unit 1 was northbound in a private parking lot wanting to continue northbound across Heath Rd onto another private drive. Unit 3 was southbound on the private drive across from unit 1, stopped at a stop sign. Unit 1 proceeded into the roadway and into the path of unit 2. The front of unit 2 struck the passenger side of unit 1. The front of unit 1 then slid into the front of unit 3. Unit 1 cited for Failure to Yield From Private Drive.
